The deadline for submissions is **February 28th, 2010**. Award recipients will stand out from other entries in their ability to demonstrate one or more of these basic principles:

1. Mix Land Uses
2. Take advantage of compact building design
3. Create housing choices for a range of household types, family sizes and incomes
4. Create walkable neighborhoods
5. Foster distinctive, attractive communities with a strong sense of place.
6. Preserve open space, farmland, historic buildings and critical environmental areas
7. Strengthen existing communities and achieve more balanced regional development
8. Provide a variety of transportation choices
9. Make development decisions predictable, fair and cost effective.
10. Encourage citizen and stakeholder participation in development decisions
11. Utilize clean energy and green building development
