What are Complete Streets?

Complete Streets is a policy that designs and builds roads for all users, including bicyclists, public transportation vehicles and passengers, motorists, and pedestrians of all ages and abilities. A New York State bill would amend the state highway law and would apply to the planning, design, construction, reconstruction, and rehabilitation of state roadways. Design features would include sidewalks, bicycle lanes, lane striping, share the road signage, crosswalks, buss pull outs, curb cuts, traffic calm-

Complete Streets in New York

To date, at least 15 municipalities in New York State have passed local Complete Streets laws, including five towns on Long Island (Babylon, Brookhaven, Islip, North Hempstead, and Southampton). Unfortunately, these local policies only apply to local roads, necessitating a broader state policy. Many of the most dangerous roads are state roadways, such as Sunrise Highway and Hempstead Turnpike. At least 25 other states have also implemented Complete Streets legislation.

In 2010 a the Complete Streets bill passed the Senate but failed to get by the Assembly. With little time left in the current legislative session, it is a critical moment to tell Governor Cuomo and your state representative that you care about making New York's roadways safer and more inviting to all users.

Support Senate bill S.5411, and urge the Assembly to follow suit!
